SECTION 1: PROJECT OVERVIEW

Summary

The Town of Landis, hereafter referred to as the "Town", is accepting Proposals from vendors for the replacement of sidewalks in downtown Landis. Qualified vendor(s) will be able to provide the following needs for this project.

North Central Sidewalk Replacement Scope of Work

- Demolish and replace sidewalk and curb along East side of North Central Avenue from East Ryder Avenue to East Garden Street.
- Curb and gutter elevations be adjusted to meet ADA guidelines for new sidewalk.
- New sidewalk to be poured at 4" thick between new curb and existing buildings.
- Driveway entrances to be poured at 6" thick.
- Driveway beside Par 3 Insurance needs to be widened to 22' with 3' fan entrance. Start point for driveway to be determined but will be discussed in Pre-Bid walk through.
- 2 handicap ramps at existing locations need to be replaced and brought up to ADA guidelines.
- Replace/repair one stormwater catch basin and grate.
- Demolish existing pavement parking area on East side of North Central Avenue and pour 18' concrete apron.
- Apron should be replaced with 4" of ABC and 6" of 6,000psi concrete.
- Stripe parking areas to match the existing layout.
- Demolition in front of businesses, to be performed after business hours or at night. All other demolition to occur at the contractor's discrepancy.
- Multi-mobilization is recommended but not required.
- Provide all equipment, labor, and materials

Section 2: Proposal

Vendors are required to submit a proposal that presents the vendor's qualifications and understanding of the items to be purchased Proposals must be clearly marked "North Central Sidewalks" and submitted no later than Monday, December 2, 2024, by 2:00 PM. Sealed proposals must be mailed, or hand-delivered to:

No submissions or supporting documents will be accepted after this deadline. The Town of Landis assumes no responsibility or liability for costs incurred by the responsive vendor in

submitting this proposal. Vendors accept all risks for late delivery of the Proposal Package, regardless of fault.

IMPORTANT NOTE: All employees of the selected contractor will be required to submit to a background check prior to working on site.

Proposal Content

1. Proposal Form & Signature Page

The proposal form and signature page must be completed and signed by an individual authorized to bind the vendor. All proposals submitted without such proposal form and signature page may be deemed non-responsive.

2. <u>References</u>

Proposals shall include a list of three (3) references including name, address, phone number, and contact person. The Town reserves the right to contact references other than, and/or in addition to, those furnished by a vendor.

- <u>Company Narrative</u> Provide information regarding your experience level, years of operation, etc.

- 5. Independent Contractor Statement
- 6. <u>E-Verify Affidavit</u>

SECTION 3: OTHER PROCEDURAL INFORMATION

4.1 Other Procedures and Conditions

The Town reserves the sole discretion and right to reject any and all responses received with respect to the RFP and to cancel the RFP process at any time prior to entering into a formal agreement. The Town further reserves the right to request additional information or clarification of information provided in any response. The Town also reserves the right, but is under no obligation, to waive technicalities and informalities. The Town shall make the award as deemed in its best interest. A response to this RFP should not be construed as a contract, nor indicate a commitment of any kind.

4.2 Public Records

Upon receipt by the Town, your Bid Package is considered a public record except for material that qualifies as "Trade Secret" information under North Carolina General Statute \$66-152 et seq. Your Bid Package will be reviewed by Town staff, as well as members of the general public who may submit public record requests. To properly designate material as a trade secret under these circumstances, each firm must take the following precautions: (a) any trade secret submitted by a firm should be submitted in a separate document marked "Trade Secret - Confidential and Proprietary Information - Do Not Disclose Except for the Purpose of Evaluating this Bid Package," and (b) the same trade secret/confidentiality

designation should be stamped on each page of the trade secret materials contained in the document.

In submitting a Bid Package, each firm agrees that the Town may reveal any trade secret materials contained in such response to all staff involved in the evaluation process and to any outside consultant or other third parties who are hired to assist in the evaluation process. Furthermore, each firm agrees to indemnify and hold harmless the Town and each of its officers, employees, and agents from all costs, damages, and expenses incurred in connection with refusing to disclose any material that the firm has designated as a trade secret. Any firm that designates its entire Bid Package as a trade secret may be disqualified from the evaluation process.

SECTION 4: Minority Business Enterprises

The Town of Landis is committed to using Minority Business Enterprises (MBE) for professional services and other Town contracts. Vendors and teams demonstrating a commitment to assist the Town in attaining this goal by being or including qualified MBE firms will be given priority consideration in the evaluation process.

For purposes of this section, the term minority refers to a person who is a citizen or lawful permanent resident of the United States and who is:

- Black, that is, a person having origins in any of the black racial groups in Africa;
- Hispanic, that is, a person of Spanish or Portuguese culture with origins in Mexico, South; Central America, or the Caribbean Islands, regardless of race;
- Asian American, that is, a person having origins in any of the original peoples of the Far East, Southeast Asia and Asia, the Indian subcontinent, the Pacific Islands;
- American Indian, that is, a person having origins in any of the original peoples of North America; or
- Female

In order to qualify as a Minority Business Enterprise, the vendor must have a majority ownership of minority partners and must:

- Be a NC Department of Administration certified Historically Underutilized Business
- Be a NC Department of Transportation certified Disadvantaged Business Enterprise; or
- Seek approval as a qualified MBE at least two (2) weeks prior to the due date of the responsive submittal to the associated procurement process.

Vendors or team member vendors that are qualified MBEs need to complete and return the Attachment with the submittal documents for this project. Evaluation committee members will be given guidance on scoring MBE participation rate based on the role of the MBE vendor (prime or sub), the number of MBE vendor(s) on the team, and the experience of the team members working with the MBE vendor(s) proposed.
